

## COVID-19 Vaccination SUITABILITY ASSESSMENT Non-VR GP (MDRAP, PEP or 19AB Exemption) (July 2021)

- The vaccine suitability assessment service is free to patients and the MBS items must be bulk billed.
- Where the service is provided on behalf of the GP/OMP there is no requirement for the practitioner to be in the same room as the patient. However, it should be noted that the practitioner billing the item is taking full responsibility for the service and must ensure they are available at the location if clinically required.
- Please note that if your practice is not one of those selected to receive the vaccine for administration then you are not eligible to claim the new MBS items for your patients.
